ADMINISTRATIVE REPORT - Executive Director & Administrative Services Manager

Busy with governor's office with reporting and with our WMBE reporting. Working on our 2017 construction campaign. Closed a majority of our grants from last year and are applying for new security grants/TIGER grants. It's be a fairly mild winter and have a lot of salt left. We've been working with Novelis around their schedule for aluminum shipments and grain is doing fairly well. Quoting a lot of cargo shipment requests, but am getting feedback on our costs being too high. 2016 will be equally as busy and should be a banner year for cargo even with all the construction. We are investing a lot into our infrastructure. Working on improvements in the marina and installing a launch ramp to help increase boat traffic. Cayuga County will benefit from the \$500 million awarded to Onondaga and the inland port especially for importing products. We're still working on getting container business.
