ADMINISTRATIVE REPORT – Executive Director

We continue to be busy with aluminum and record grain numbers. There have been a steady line of grain trucks daily. We will have a grain ship here this Wednesday to load out soybeans, freeing up the domes to fill again. With the assistance of the SUNY Interns doing the certifying and grading, we now are able to export grain to a wider market. At the end of the month we expect to see our first container ship carrying in German machinery parts and beer machinery components. I've been doing a lot of quotes for shipping out car parts and bringing in beer tanks. We had a couple railcars bringing aluminum slabs here as a test to see if we were able to unload them and we did very well. This could lead to future shipments of them to us. We were able to get some jersey barriers for free.
