# THE PORT OF OSWEGO: UPSTATE IMPACT, GATEWAY TO THE WORLD

### PORT MOVING FORWARD



**Goble Deep-Water Marina –** \$2.1 million deep-water marina on the site of the former Goble Dry Dock and Shipyard, adjacent to the Port's West Pier. Open for 2024 season.



**East Dock Upgrade** – The Port has invested over \$3.5 million in dock upgrades. This will expand the number of vessels served and enable two ships and a barge to tie up simultaneously.



**\$35 Million Break Wall Repair –** Port Executive Director William Scriber requested earmarked federal funding for the project. This will repair the entire harbor break wall— including repairs to foundation of Oswego's iconic West Pierhead Lighthouse.



**Rail Yard Expansion –** The Port was awarded \$5 million in grants to purchase an all-electric rail engine (\$2 million) and make major upgrades to its rail service at its Fitzgibbons Intermodal Terminal (\$3 million). Construction of a fifth storage track making the port the largest operating yard in Oswego County.



**55,000 lb. Forklift** – This massive machine was purchased to handle a new product line in 2024.

**Foreign Trade Zone Goes "Live" –** The Port secured its first FTZ customer who is warehousing product to save money on duties and tariffs.



**Interlake Container Project –** The Port has secured funds for a study by the United States Department of Transportation to establish the Port as an Interlake container facility.

**Mountains of Aluminum –** The Port finished 2023 with an intake in December of over 74,000 tons of aluminum (over 100,000 aluminum ingots) which is a 243% increase during the same time since 2018.



**Specialty Freight –** The Port moved over 11,000 tons of specialty freight in 2023. These included components for a new Lithium battery recycling facility in Rochester, a Novelis production line update, and a transformer for a nuclear power plant.
