## **SEQR Part 3 Explanations**

<u>Part 2, Question 1:</u> The Port's Vinegar Hill RV Facility site is currently zoned by the City of Oswego as "Transitional Business" (TB) district. The use type proposed is considered, "Non-Residential Uses: Recreational Uses, Outdoor Recreation" which is considered a "Prohibited Use".

The Port of Oswego is a New York State Authority established by the NYS Legislature in 1955 (Title 2, Port of Oswego Authority; Public Authorities (PBA) Chapter 43-A, Article 6) is not subjected to or required to follow or comply with local zoning requirements. The proposed use of the site for the purpose of providing short term occupancy accommodations for approximately 12 Recreational Vehicles (RVs) is consistent with the Port's Vision 2030 Comprehensive Plan and its jurisdiction as authorized by the NYS Legislature.

Per Section 1352, Oswego port district. There is hereby created and established a district to be known as the "Oswego port district" which shall embrace the city of Oswego, the town of Scriba and all lands and water under and in the Oswego river and Lake Ontario lying or situated within the boundaries of the city of Oswego and/or the town of Scriba subject to the right, title, interest and control of the state under the constitution or any law of the state of New York and subject to the right, title, interest and control of the United States under any law of the United States of America.

Per Section 1354, The authority shall have power over the survey, development and operation of port facilities and industrial projects in such port district as hereinafter more specifically set forth, and the coordination of the same with existing or future agencies of transportation with a view to the increase and efficiency of all such facilities and projects and the furtherance of commerce and industry, environmental protection, aesthetics, health, welfare, safety, recreational opportunities, and historical appreciation in the district.

Part 2, Question 5: The RV facility will have approximately 12 sites available and operate on a seasonal basis between May and October and be closed between November and April. Traffic generated by the sites proposed use will consist of RV's arriving and departing from the site and trips by guests which will result in a slight increase of traffic volume however, it will not have an adverse impact the overall flow of traffic or traffic conditions in the area.

<u>Part 2, Question 7b:</u> Individual RV sites will have connections via a gravity fed system that will be collected into a 1,200 gallon above ground holding tank. The holding tank will be cleaned out on a regular basis by a contracted provider registered to perform the clean out service.

Part 2, Question 8: The Vinegar Hill RV Facility is located substantially contiguous to the Fort Ontario historic site. The proposed use of the site for the purpose of providing short term occupancy accommodations for approximately 12 Recreational Vehicles (RVs). The proposed action will have no physical impacts to the adjacent Fort Ontario site. This proposed action will require no disturbance on the site extending beyond what has previously been disturbed, will not construct any permanent buildings or structures and will not physically alter or change the existing characteristics of the site.

Part 2, Question 9: The Vinegar Hill RV Facility is located near the Oswego River approximately 600 feet west of the site, the Port's East Marina channel approximately 150 feet west of the site, and Lake Ontario approximately 1,400 feet north of the site. The proposed use of the site will not impact or result in any alterations to these water bodies.
